2022-2023 Verification Worksheet Independent Student

You and at least one parent must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the Financial Aid Office. The Financial Aid Office may ask for additional information. Failure to submit the required forms within 60 days may result in your financial aid application being denied. If you have questions about verification, contact the Financial Aid Office as soon as possible so that your financial aid will not be delayed.

1. Tax Return Filers — Important Note: If the student filed or will file an **amended** 2020 IRS tax return, the student must contact the Financial Aid Office before completing this section.

Instructions: Complete this section if you, the student, **filed or will file** a 2020 income tax return with the IRS. *The best way to verify income is by using the IRS Data Retrieval Tool that is part of FAFSA on the Web. If you have not already used the tool, go to www.studentaid.gov, log in to your FAFSA record, select "Make FAFSA Corrections," and navigate to the Financial Information section of the form. From there, follow the instructions to determine if you are eligible to use the IRS Data Retrieval Tool to transfer 2020 IRS income tax information into your FAFSA. It takes up to two weeks for IRS income information to be available for the IRS Data Retrieval Tool for electronic IRS tax return filers, and up to eight weeks for paper IRS tax return filers. If you need more information about when, or how to use the IRS Data Retrieval Tool see your financial aid administrator.*
